 - -"It was me, but s/he said it was OK!"



A 19 year old woman is approached by	
two unknown males while walking home. One of the men (Man A) is armed with a	
pistol. Man A tells the woman to walk to a secluded area of a nearby park. Man A orders her to take off her clothes and	
then both Man A and Man B have sex with her. Neither man ejaculates.	
What can Man A be arrested for?What can Man B be arrested for?	

- A 21 year old woman is at a fraternity party and becomes intoxicated.
 Eventually she is escorted, by her boyfriend, into his bedroom where she takes off her own clothes and then passes out. Her boyfriend rubs against her naked body until he ejaculates.
- What, if anything, can the boyfriend be arrested for?

Scenarios

- A woman's husband tells her that he is going to strangle her if she does not agree to perform oral sex on one of his friends while the couple is camping.
- What, if anything, can the husband be arrested for?
- What, if anything, can the friend be arrested for?

- A female resident of a group home who is significantly cognitively disabled voluntarily has sex with a male member of the group home staff.
- What, if anything, can the man be arrested for?

- A man reaches around a woman seated at a bar and while pretending to pay for a drink he grabs her breast.
- What, if anything, can the man be arrested for?

Scenarios

- A man comes home and tells his wife to take her clothes off so they can have sex. She refuses so he undresses her, pushes her legs open, and has sex with her. She does not resist physically but says, "Leave me alone!"
- What, if anything, can the man be arrested for?
- If she becomes pregnant as a result of that incident does that change the charging decision?

No physical evidence of injury is observed and no evidence is collected. The suspect is confronted and denies that there was intercourse and has an alibi.

- A woman reports to police that she was forced to have sexual intercourse by a stranger and gives a detailed statement. Evidence is recovered and a suspect is developed from a line-up. The suspect is confronted and denies ever seeing the victim and has an alibi, and his DNA does not match what was recovered from the scene.
